Ensure that you have done adequate revisions and practice questions before attempting the exam so that you increase your chances of passing in the first attempt itself which will motivate you to pursue and finish the remaining papers.

Secondly, ensure proper time management especially if you are working and studying for the examination. Do not study at the last minute and ensure you have sufficient time gap planned between your study period and the date of your exam.

Thirdly, ensure that you have adequate practice of questions under timed conditions using your online learning approach so that you are aware of the time management required when answering questions in the actual exam and have sufficient knowledge on key areas within the syllabus.
